## **SacRT is Moving Forward** *Major Service Improvements to Bus Network Arrives September 8, 2019*

The Sacramento Regional Transit District (SacRT) is moving forward with improvements that reduce congestion and lead to economic growth. A new bus network, called SacRT Forward, launches on Sunday, September 8. Almost every bus route will be adjusted to improve frequency, scheduling and weekend service.

As part of the project, new bus stop signs will be installed at bus stops throughout SacRT's service area. The new signs not only feature a new look, but also include the bus route destination and the bus stop number on both sides of the sign.

The SacRT Street Team is out riding bus routes talking with riders about the upcoming changes and improvements. The SacRT Forward

outreach bus will be traveling to community events and transit centers this month. SacRT staff will provide information about the new bus network and trip planning assistance on board the outreach bus.

There are adjustments to almost every bus route making the new bus system user-friendly with more direct routes seven days a week. The new bus network improves trips to key activity centers (jobs, education, entertainment and more) throughout the region. The new bus network will have better timed buses to connect riders to light rail trains.

We've created a network that not only serves the community today, but anticipates expansion into the future. The new bus network has the potential to connect one million people to 500,000 jobs within half mile of each bus stop.

## CalFresh for People Receiving SSI

Exciting news on the approved Expansion of CalFresh to Seniors and People with Disabilities Receiving SSI starting on June 1st 2019; We will have presentations at resident committee meetings, the purpose is to communicate the exciting news and have everybody ready to apply for CalFresh during the Summer.

Please note:

SSI benefits will NOT be reduced or eliminated because of this change.

Excluded SSI members of current CalFresh households DO NOT need to apply: SSI members will be added to existing CalFresh households at the next semi-annual or annual report after implementation; or the household can make a voluntary request to add the SSI member any

time after implementation.

Most SSI recipients and couples living on their own, will be newly eligible for CalFresh. If approved, they will receive an EBT card with CalFresh food benefits loaded monthly.

Established in November 1993, Northern California Construction Training, Inc. (NCCT) is a building trade's pre-apprenticeship training program that helps prepare men and women for entry into various construction trades apprenticeship training programs. NCCT is a non-profit, community-based organization. NCCT has a general contractor's license. Their carefully selected staff of credentialed teacher-trainers is experienced in construction and is highly motivated.

During the program students receive unpaid training in the classroom as well as hands-on building experience in Construction Trades work under the supervision of a journeyman carpenter. When the student is successful in completing the training program he/she will be offered an opportunity to join the construction trades apprenticeship training program of his/her choosing; when positions are available. These apprenticeships positions start anywhere from \$14.00 to \$23.00 per hour, depending on the trade and benefits.

Many potential construction workers are not aware of the career opportunities available to them. This is especially true for women and minorities. NCCT was formed to make well-paying careers in construction available to anyone with the desire to complete the program and participate in apprenticeship training. Since their doors opened, NCCT has trained thousands of students in our adult programs, in-custody jail program,

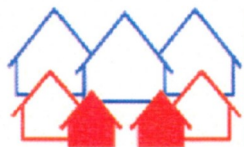
