# The Affordable Care Act (ACA) known as Obamacare By Gerald Booth

The Affordable Care Act. commonly called Obamacare, was created to expand access to affordable health care coverage to all Americans , with lower costs and improved quality and care coordination. There have been and will continue to be many changes to implementing this law. I will briefly cover 3 main groups affected by these changes. Medicare and Medical Beneficiaries, Veterans and Individuals and families.

Medicare isn't part of the Health Insurance Marketplace established by ACA, so you don't have to replace your Medicare coverage with Marketplace coverage.

Since 2011, California has been taking steps

towards expanding Medicaid (Medi-Cal) under the Affordable Care Act (ACA) by implementing Low Income Health Programs (LIHPs) in most California counties. Under the "Bridge to Reform" Medicaid §1115 waiver. just over 500,000 California adults are currently enrolled in coverage in advance of ACA implementation using federal and county funds. The vast majority of these LIHP enrollees can become eligible for Medi-Cal coverage under the ACA beginning January 1, 2014, and the remainder will be eligible for subsidies through Covered California (the California Health Benefit Exchange).

At a glance, if you are enrolled in VA health

care, you don't need to take additional steps to meet the health care law coverage standards. The health care law does not change VA health benefits or Veterans out of-pocket costs. If you are not enrolled in VA health care, you can apply at any time. The VA wants all veterans to get healthcare that improves their health and well-being.

Individuals and families will be able to find health insurance from either their current employer or if that is not available , then they can find health insurance plans through either the private exchanges or the public exchange called Covered California. There are calculators on these web sites to determine the monthly costs and how much will

# Medi-Cal Members: Get Free Patches in the Mail!

Starting Sept. 30th,
Medi-Cal members who
want to quit smoking
can get free nicotine
patches by mail from the
California Smokers'
Helpline. The Helpline
will send eligible
members a free, four-

week supply of patches, with further refills as needed.

Medi-Cal members no longer need a prescription from a doctor or a certificate from a quit smoking program to get their patches. Starting Sept. 30th Medi-Cal members can call the Helpline and the patches will be delivered to their apartment within 2 - 3 business days.

Free patches will be offered to adult tobacco users age 18 and over who have a valid Medi-Cal ID and enroll in Helpline counseling. Helpline staff speak 7 languages and welcome all callers.

Also, Medi-Cal members can receive a free \$20 gift card bonus. To be eligible, they must ask for the gift card, have a valid Medi-Cal ID, and complete the first counseling session.

This program is funded by a grant from the Centers for Medicare and Medicaid Services under the Affordable Care Act (Obamacare).

#### HELP WITH COVERED CALIFORNIA

If determined to be eligible, an individual or families can get Medi -Cal as long as they continue to meet the eligibility requirements.

Consumers who are eligible for premium assistance and improved benefit plans pay less for health insurance when they buy a Covered California Health Plan. The amount they pay depends on their annual household income and percent of Federal Poverty Level (FPL)

As a licensed California insurance agent in the process of certifying to become a Covered California agent, I recommend that you call Covered California offices, go to their website or call me after October 1, 2013 for an explanation of the benefits and costs for Covered California Plans. There is a lot of information here and you probably will need a navigator or insurance agent to help you with your choices. Covered California,
