## HUD AWARDS \$30 MILLION TO SACRAMENTO TO REVITALIZE HOUSING AND SURROUNDING NEIGHBORHOOD

U.S. Department of Housing and Urban Development (HUD) Principal Deputy Assistant Secretary for Public and Indian Housing Lourdes Castro Ramirez joined Mayor Kevin Johnson in Sacramento today to announce that SHRA and the City of Sacramento will receive a \$30 million Choice Neighborhoods Implementation Grant to redevelop the distressed Twin Rivers public housing community and revitalize the Sacramento River District-Railyards neighborhood. Sacramento was one of five recipients.

"This is a reflection of the direction that Sacramento is headed and how the federal government is a continued partner in our region's success," said Congresswoman Doris Matsui. "The housing and infrastructure at Twin Rivers is old and must be replaced. This grant will help us

replace the housing, improve the transportation connections to the neighborhood, and implement a number of social services that will benefit the area's residents. I am confident that this grant will truly transform our community. I am thankful for HUD Secretary Julián Castro's commitment to our city, as well as SHRA's efforts to bring this effort to fruition."

As part of the Administration's overall drive to reinvest in neighborhoods of concentrated poverty, President Obama's Choice Neighborhoods Initiative (CNI) is intended to transform distressed public and assisted housing into sustainable, mixed income housing with access to

community assets and services to support positive outcomes for families living in the development and in the surrounding community. For every \$1 in CNI funding, Sacramento and more than 35 partners will leverage an additional \$9 in public and private investment for the project.

"This CNI award is a game-changer for Sacramento," said Sacramento Mayor Kevin Johnson. "For too long the Twin Rivers community has remained underserved. Thanks to CNI, it will be revitalized and reconnected to our downtown, which is becoming one of the country's most exciting urban hubs. I deeply appreciate the support of HUD, SHRA, and our other public and private partners as we work together to create a city that works for everyone."

"We are extremely proud that HUD has selected Sacramento for a 2015 Choice Neighborhoods Implementation Grant

to help transform the Twin Rivers community and surrounding area," said SHRA Executive Director La Shelle Dozier. "The countless hours of engagement from residents, community members and public-private partners over the past three years has really paid off, and we're very excited to continue building on the investment we've already made to successfully transform this community and significantly improve quality of life for everyone who lives here."

The Twin Rivers plan calls for one-forone replacement of the existing 218 units included in a total of 487 mixed income housing units both on and offsite. Implementation Grants support those communities that have undergone a comprehensive local planning process and are ready to implement their Transformation Plan to redevelop the neighborhood.

Today's announcement follows designation of Sacramento as a federal

Promise Zone last April which includes the Twin Rivers area and will support comprehensive community revitalization efforts by providing additional federal resources to highpoverty communities throughout the country.

"We have a phenomenal opportunity to transform the neighborhood and transform lives," said SHRA Director of Development Tyrone Roderick Williams, who was recently named Director of the Sacramento Promise Zone. "We have an exceptional team and committed, experienced staff and we will succeed at creating a revitalized diverse neighborhood of choice."

The grant will provide additional resources to dozens of partner organizations to provide enhanced services to Twin Rivers public housing residents to improve outcomes in health, education and employment.

The grant requires the project to break ground in the next 18 months.
